1. Hold Fee, Payment, and Purchase Price

Buyer has paid a hold fee of \$_____, with payment of the balance of \$_____ due upon release of the dog to the buyer. The expected delivery date is: _____, or such other date as the parties mutually agree. Payment may be made by cash, money order, Venmo, or Cashapp. If the dog is being delivered via airline nanny, the dog must be paid in full, including the price of delivery, no later than the night before the flight. Payment for the flight must be made at the time of booking the flight nanny.

Buyer acknowledges and agrees that buyer will forfeit the hold fee and the rights to the dog if:

- (a) Buyer fails to complete the purchase of the dog for any reason, or
- (b) Buyer fails to pay the balance of the purchase price before arrangements are made for pickup/delivery.
- (c) The dog is not picked-up or delivered within 3 weeks of the ready date, unless prior arrangements were made prior to purchase or it is due to unavailability of the flight nanny.

In either event, Breeder shall be free to sell the dog to another party.

In the event, that the dog is not available due to sickness, death, or any other circumstance owing to the fault of Breeder, Buyer's hold fee will, at Buyer's option, be either refunded, or transferred to the next litter of puppies.

2. Breeder Representations and Warranties Breeder represents and warrants to buyer that:

- (a) Breeder is the legal owner of the dog and has the full right and authority to sell the dog.
- (b) Breeder guarantees that the dog is purebred, offspring of the Sire _____ & Dam _____.
- (c) To ensure that the buyer does not euthanize the dog, take it to a shelter, or re-home it, the breeder will take the dog back at any time in the dog's life, at the expense of the buyer. The buyer MUST notify the breeder if any of the above situations are a possibility. Medical records and papers will be returned with the dog.
- (d) The breeder guarantees the puppy to be of sound health and temperament at the time of sale. This puppy has been treated for internal and external parasites, received preventative vaccinations for canine distemper, parainfluenza, and the parvo virus. A health record of shots and worming will be provided by the breeder. **IMPORTANT:** If your vet will not acknowledge the shot/worm record provided by us, please contact us so we can speak with them and provide any additional information they may need. **DO NOT LET THEM GIVE THE SHOTS AGAIN.** Over vaccinating can seriously harm and/or kill the puppy.
- (e) Health Guarantee: The breeder takes pride in producing good quality, healthy dogs, with wonderful temperaments to loving homes. The breeder guarantees the dog's health for the first 6 months of the puppy's life. The breeder guarantees this dog to be free from life-threatening, inherited diseases. With all live species, environment, nourishment,

exposure, climate changes, and genetic conditions can affect the long-term health of the puppy. Environmental facts can cause: allergies, thyroid dysfunction, demodectic mange, and autoimmune disorders. Development of Osteochondritis Dissecans, Elbow or hip dysplasia, or any form of turn out in legs, Entropion, Ectropion Cataracts, and other eye conditions. Behavioral problems such as aggression or unacceptable personality traits are the responsibility of the owner. Buyer understands that the following slight genetic defects are not life-threatening: Umbilical or Inguinal hernia, undescended testicles, under/overbite.

3. Buyer's representations

Buyer represents to seller that:

- (a) _____ The dog will reside with the buyer as companion pet to buyer and buyer's family.
- (b) _____ Buyer will keep the dog in an enclosed area of adequate size and not allow the dog to roam at will. Buyer will not keep dog chained or tethered to an inanimate object in a yard or keep the dog permanently in a kennel since research shows this causes anti-social behavior in dogs. Also, the buyer will provide nutritious food and necessary healthcare by a licensed veterinarian, including appropriate worming and vaccinations.
- (c) _____ If this puppy is being sold for pet, companion only, the buyer agrees not to use the dog for breeding, and understands that LIMITED REGISTRATION will be given, which means that the dog cannot produce AKC registerable litters. However, it may participate in most AKC events.
- (d) _____ Buyer understands that replacement of the puppy is only an option when valid health problems are attributed to a hereditary problem that is LIFE THREATENING and not due to an accident or illness. Buyer understands that all guarantees expire when the puppy reaches 6 months of age, or if the puppy receives any vaccines within 10 days of purchase.
- (e) _____ In the case of fatal, life threatening disorder the buyer must provide all test, the radiography should permanently identifiable in the film emulsion with, name of puppy or registered name and the name of veterinarian. Furthermore, the radiography and report must meet OFA standards submission requirements. The seller must be notified within (2) business days of licensed veterinarian diagnosis and have (2) two reports from (2) two separate veterinarian clinics stating the same problem. A replacement puppy of equivalent value will be provided as soon as a comparable puppy is available. If the puppy dies within this health guarantee time frame Owner will pay to have a necropsy to ascertain reason of death. NO replacement puppy or refund will be given if puppy has been euthanasia without breeders written consent. No veterinarian or test will be at breeder's expense in this event.

Most puppies are ready to go to their new homes at 8 weeks of age, however, if we feel a puppy is not ready to travel, the date could change.
